## 1. How we use your information

This privacy notice tells you what to expect when we collect personal information. It applies to information we collect about:

- Visitors to our websites
- People who use our services (i.e. retail and professional clients)

## 2. Visitors to our websites

When someone visits our websites we collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. We collect this information in a way which does not identify anyone. We will not associate any data gathered from cookies on this site with any personally identifying information from any source.

## 3. Cookies

Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our website and also allows us to improve our site.

Cookies are small text files that are placed on your computer by websites that you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site.

Site Cookie acceptance	ff.metacookie	This cookie is used to record if a user has accepted the use of cookies on our website.	
Campaign Source	ams_cid	Stores the ID of the media (marketing email, portal site, google adwords banner, etc.) from where the visitor was referred. Only present on certain landing pages, not on the homepage.  This cookie is stored for 60 days. It does not contain any information other than the media ID (for example 20120125fb).
